



## CHECKLIST

- ☐ For a patient who has presented to the ED multiple times in the last year, perhaps with exacerbations of ongoing conditions, consider asking the Surprise Question: Would you be surprised if this patient dies within the next few months/weeks/days? Is it time to initiate a conversation about end-of-life care?
- ☐ Check if the patient has an existing Advance Care Plan. If they have not yet started a discussion about their end-of-life care, be proactive and [start the conversation](#).
- ☐ When talking to a family member about a patient who is at the end of life in the ED, ensure there is a common understanding of the patient's condition, focus on finding out what the patient would want based on their own beliefs and values, listen and hold space for family members, and frame discussions around goals rather than specific treatments.
- ☐ Remember, families and patients can feel a variety of emotions when end-of-life care is provided, or death happens in the ED. Be prepared for strong emotions. Anger and utter sadness are common, along with a genuine surprise that death has occurred, even when the death may have been expected.
